1 Call to Order

Chairman Nowlin called the August 6, 2018, Planning Commission Meeting to order at 7:04 p.m., at City Hall, 16600 Civic Center Drive, Bellflower.

7-A Zoning Ordinance Text Amendment - Consideration and possible action to conduct a public hearing to consider a Zoning Ordinance Text Amendment; and adopt Resolution No. PC 18-10 - A Resolution recommending the City Council approve Zoning Ordinance Text Amendment Case No. ZOTA 18-03 amending Chapter 17.48 of the Bellflower Municipal Code (BMC) regarding parking standards for public assembly uses in the Town Center (TC) District, including but not limited to, allowing public assembly uses in the TC District to transfer required on-site parking spaces to off-site parking areas subject to a parking agreement, establish implementation criteria for the use of public parking facilities, correctly reference the parking fee as an "in-lieu fee" instead of an "impact fee," and correctly reference "Parking District No. 1" instead of "TC Parking District."

Assistant Planner Brun briefly reviewed the staff report highlighting the history, background, and the proposed project. She along with Planning Manager Genilo-Concepcion answered Commission questions relative to: 1) whether it should be noted that Chapters 17.48 and 17.88 were being amended, and 2) why the new parking structure north of Mayne Street was not included in the parking assessment.

A discussion ensued between the Commission, Assistant City Attorney King, and staff relative to: 1) Parking District No. 1 Assessment, and 2) the possibility of extending the assessment area to include other parking lots.

Assistant City Attorney King clarified: 1) the ordinance would apply to all uses, not just public assembly, 2) the assessment was approved by the property owners and not imposed by the City without their consent, 3) staff can relay the Commission's concerns on the assessment to the City Manager, 4) the assessment is not a zoning or planning issue, and 5) the ordinance gives more flexibility for all uses, allows them to have off-site parking, and pursue parking "in-lieu fees" as well.

Chairman Nowlin opened the Public Hearing and seeing there was no one wishing to speak for or against the project, Chairman Nowlin closed the Public Hearing.

It was moved by Commissioner Sanchez, seconded by Commissioner Franzen, and carried by the following roll call vote, to adopt Resolution No. PC 18-10, recommending approval of Zoning Ordinance Text Amendment Case No. ZOTA 18-03, subject to findings as presented:
