A. Conditional Use Permit / Development Review Planner: Kathryn Brun

Consideration and possible action to conduct a public hearing to consider an application from Jacob Sonenshine (representing Prell Bellflower, LLC) for a Conditional Use Permit and Development Review; and adopt Resolution No. PC 18-11 – A Resolution approving Conditional Use Permit Case No. CU 18-06 and Development Review Case No. DR 7-18-9191 to construct a new 2,400-square foot building with two tenant spaces, one of which is a drive-through facility, within the Design for Development for the South Bellflower Commercial Area (DFD) on property located at 17404 Bellflower Boulevard. *(Continued from the September 4, 2018, Planning Commission Meeting).*
