Consideration and possible action to conduct a public hearing to consider an application from Steve Phillips (representing Gardening at Nite, LLC) for a Conditional Use Permit, and adopt Resolution No. PC 18-13 – A Resolution approving Conditional Use Permit Case No. CU 18-08 to allow on-site and off-site sale and consumption of alcohol (Type 21: Off-Sale General, Type 23: Small Beer Manufacturer, Type 47: On-Sale General Eating Place and Type 74: Craft Distiller). The subject property is located within the Design for Development for the South Bellflower Commercial Area (DFD) at 17434 Bellflower Boulevard.

Pursuant to the authority and criteria of the California Environmental Quality Act (CEQA), an environmental assessment has been conducted for this project. This project has been determined to be Categorically Exempt (Class 1, § 15301) because the proposed project consists of a negligible expansion of the use.
