O. PUBLIC WORKS SECURITY DEPOSITS

The City will collect a security deposit from applicants requesting or required to perform work in the public right-of-way. If the work is performed to the City's satisfaction, then the deposit will be refunded to the applicant. If the work is not performed or is not performed to the City's satisfaction, then the City will use the deposit to complete the work. If the amount of the deposit exceeds the City's costs, then the surplus will be refunded to the applicant. If the amount of the deposit is less than the City's costs, then the City may seek to recover the additional cost from the applicant.
